Instructions

During the last afa-CWA campaign, some afa-CWA activists engaged in inappropriate behavior. These activists badgered and cajoled us until we signed cards just to make them go away. In some cases, their behavior crossed the line from advocacy to intimidation. In this campaign, we feel that the afa-CWA activists should conduct a campaign free of intimidation.

We support the right of the afa-CWA activists to speak their minds to the extent of their ability. We think it fair that they are allowed to express opinions different from ours. As long as their advocacy is conducted in the proper places at the proper times and in the proper manner, we support their right to conduct organizing activity. However, some afa-CWA activists do not care if their behavior crosses the line. They are so committed to getting themselves into power, they will distort the truth and try to intimidate anyone who disagrees with them.

In this new campaign, we believe that these activists need to be held accountable for any inappropriate behavior. Therefore, deltafa.org has created a tool to help keep this campaign clean. This form is that tool. With it, you can communicate any transgressions to the only department that can keep the activists within acceptable behavior. This form will provide information that will help rein in those activists who engage in inappropriate behavior and hold them accountable for crossing the line.

What is inappropriate behavior? Some examples are, but not limited to:

- Continuing phone calls after you have asked the afa-CWA to cease contact
- Physical threats
- Vandalism to your property
- Having your name circulated on a printout of card signers or "yes" voters
- Having it pointed out that your name is **NOT** on this list
- Over 3 pounds per week of afa-CWA junk mail in your mailbox
- "Drop by" home visits
- Cash payments
- Sexual favors
- Being singled out in briefings or on the aircraft for your non-union position
- Verbal abuse
- Other behavior designed to coerce your decision
- Contact on the aircraft or in work areas of lounges

In this campaign, we will send the afa-CWA the message that it will have to control its people. The afa-CWA will have to play fair, and its intimidation tactics will not work this time. If an activist crosses the line, that activist will be reported and held accountable.
